

Tonopah Rob's Vegetable Farm Half Share CSA Registration Form

With my signature and submitted payment, I subscribe to Tonopah Rob's Vegetable Farm CSA Program. I may pick up eligible goods on Saturday and/or Sunday at one of Tonopah Rob's Vegetable Farm locations during the farm season. Each time I pick up eligible goods, Tonopah Rob deducts the cost from the remaining credit of my paid share. I am not obligated to pick up my share each week. I am allowed to pick up any amount of eligible goods not to exceed my credit.

My CSA Share is valid for one season. I understand that I forfeit any unused balance at the end of a season.

Payment Options: CSA subscription cost is \$250 for one Half Share. The share amount must be paid in full prior to picking up eligible goods. My CSA subscription cost is not refundable. I may not sell my paid share to another subscriber or any other party. I may extend use of my share to friends and family members or donate any unused credit to a non-profit organization.

Bonus Amount: I will receive a 5% bonus for my Half Share CSA Subscription. This bonus amount is available to me after my paid Half Share is exhausted. This Bonus Share is not refundable and may not be exchanged for cash. I may not sell my Bonus Share to another subscriber or any other party.

I may receive additional bonus amounts if I meet the following conditions:

- If I subscribe prior to August 31, I will receive an early subscription bonus of \$20.
- If I subscribe after August 31st but prior to October 15th, I will receive an early subscription bonus of \$10.
- I will receive a \$10 bonus credit if I renew my CSA membership.

Any earned bonus amount is available to me once my paid Half Share is exhausted.

Farm Stand Membership Only Share (FSMOS): Subscribers in the Farm Stand Membership Only Share CSA Program receive a \$100 credit for their CSA membership in addition to the paid share. The subscriber agrees to shop only at Tonopah Rob's Vegetable Farm Stand. FSMOS Shares are not valid at other market locations. FSMOS Shares are not eligible for early sign-up, renewal, or other bonuses.

Eligible Goods, Quality, and Availability: Subscribers may choose fruit, vegetables, eggs, fresh flowers, and raw honey as eligible goods against a CSA share. Potted plants, seeds, chicken feed, meat items, and other non food items are not eligible for the Half Share CSA program.

Tonopah Rob's Vegetable Farm and Farm Stands operate on a first-come, first served basis. Subscribers may choose any combination and weight of eligible goods desired, subject to availability. Depending on abundance, some goods may be available only at Tonopah Rob's Vegetable Farm.

Tonopah Rob's Farm produces all-natural fruits and vegetables using beneficial insects. Tonopah Rob does not use pesticides. Produce may have blemishes or may not be uniform. The occasional insect and a fair share of dirt may appear in Tonopah Rob's produce supplies.

Tonopah Rob's Vegetable Farm and Farm Stands should open in November of each year. The opening date for each season is dependent on crop maturity. Each season is expected to run through June as produce is available. Tonopah Rob's Vegetable Farm and Farm Stands are closed on Thanksgiving, Christmas, New Year's Day, Easter, Mothers' Day, Memorial Day, Fathers' Day, and Independence Day.

Tonopah Rob may be forced to postpone a weekly market from time to time to allow the farm to grow enough produce to meet harvest demands. All market locations, closures, and vegetable lists are posted on www.tonopahrob.com.

Weather, Mother Nature, and other circumstances outside of Tonopah Rob's control may cause fluctuations in harvest quality, capacity, and availability. Specific goods and produce are not guaranteed.

General CSA Subscription Restrictions:

- Tonopah Rob does not accept special orders for any CSA share. Subscribers may not request special crops to be grown and exclusively raised for personal use.
- Eligible goods procured from Tonopah Rob may not be resold directly without appropriate license from Tonopah Rob. Eligible goods may be purchased by subscribers for direct business or non-profit use, such as for restaurants, schools, or churches. Wholesale use of eligible goods is strictly prohibited.
- Tonopah Rob may impose limits on eligible goods based on harvest availability.
- Bulk orders above 10 lbs must be acknowledged by Tonopah Rob prior to order fulfillment. Please call Tonopah Rob directly for bulk order arrangements.
- Subscribers may upgrade CSA shares but may not downgrade a share.
- Subscribers may renew a CSA share at any time during a season. Any bonus shares related to the new subscription will apply.
- Potted plants, seeds, chicken feed, meat items, and other non food items are not eligible for CSA programs.
- No refunds are given for any CSA share for any reason. Subscribers may extend use of their CSA shares to friends and family members or donate the share to a non-profit organization. Subscribers may not sell unused credit to another subscriber or any other party.
